In support of strengthening student academic achievement, Arts Academy Charter Middle School receives Title I, Part A funds and must jointly develop with, agree upon with, and distribute to parents and family members of participating children, a written parent and family engagement policy that contains information required by section 1116(b) and (c) of the “Every Student Succeeds Act” (ESSA). Parents may participate by reviewing the current policy and plan, engaging in Q&A sessions at Parent or Community Events, attending Parent Teacher Organization meetings, scheduling one-to-one conversations with teachers, reviewing on-line, or submitting ideas and suggestions to the school administration. As previously stated, the policy will be:

Parents will have multiple opportunities to review the current engagement plan and provide input/feedback. **Arts Academy Charter Middle School will provide the necessary support** to its administration, teachers and staff to plan and implement effective family engagement activities.

Arts Academy Charter Middle School will use **parent engagement strategies** that are integrated and coordinated with other applicable Federal State, and local laws and programs.

Arts Academy Charter Middle School will do its best to accommodate parents' schedules by offering flexible methods of participation in each of these annual meetings and by posting meeting(s) information shared on the school website.

Arts Academy Charter Middle School agrees to implement the following statutory requirements:

Arts Academy Charter Middle School will put into operation programs, activities and procedures for the involvement of Title I, Part A parents, consistent with section 1118 of the Elementary and Secondary Education Act (ESEA). At the annual Fall Title I parent meeting (Back to School Night) Title I requirements will be explained by the CEO/Title I Federal Programs Coordinator via a PowerPoint presentation and Q&A period. The reading/language arts, mathematics, and science programs will be fully explained. Opportunities for parents to formulate suggestions for school improvement will be provided.

Arts Academy Charter Middle School will adhere to all requirements regarding the use of Title I funding—including the minimum 1% set-aside for parent engagement and parent trainings/materials/communications:

Arts Academy Charter Middle School will take the following actions to conduct, with the involvement of parents:

An annual evaluation of the content and effectiveness of this parental involvement policy in improving the quality of its Title I, Part A school will be completed.
